Volunteering to help others

This week, we asked readers to tell us about the volunteering they do. We knew you were a big-hearted lot, but the extent and variety of brokers involvement with not-for-profits was astounding ...

The Corcoran Group has its own in-house charity, **Corcoran Cares**, which supports dozens of charitable and philanthropic organizations. It has become a significant way for Corcoran employees and agents to give back to communities where they themselves work and live.

Amy Goldberger, senior associate and an East Side co-captain of **Corcoran Cares**, said, "There are so many wonderful and worthy charities that need help — especially today.

"In the East Side office, we chose charities that are under the radar and don't get the big funding. In today's environment, our agents and staff have continued to step up to the plate and contribute money out of their commissions (agents) and from their paychecks (staff) and the rewards have been more than we imagined.

for our support and give us examples of how our contribution has literally changed and transformed lives — from giving children self-esteem and the courage to perform to helping furnish apartments and create new homes for New Yorkers with mental illness."

This week, Corcoran Cares is donating two \$1,200 checks to the Harlem community — one to The Harlem School of the Arts and another to East Harlem School at Exodus House.

Brokers **Jessica Armstead** and **Bruce Robertson** lobbied on behalf of the two non-profits that help educate and inspire young children from Harlem.

A sample of other beneficiaries includes: **Pathways to Housing, Inc.**, which places chronically homeless or mentally ill New Yorkers in rentals; **Opening Act**, which provides theatre/arts programs to NYC's under served public schools; **Reading Reform Foundation of New York**, which trains inner-city school teachers to provide literacy to children; **Bottomless Closet**, which provides economically disadvantaged New York women with interview skills, business clothing and career development programs; and **Stockings With Care**, which provides families with Christmas gifts for their children.

Arlene Weissburg, vice president associate broker at Corcoran, is also involved with a group called Voices

of New York, a local chapter of the national organization the **Colon Cancer Alliance**.

"We convey the importance of early screening and awareness for any changes to your digestive system," Arlene said.

"We have noticed younger people contracting this disease, so awareness is key to saving lives. There are seminars available and support groups to family members, care givers and survivors. There is also a run in Central Park in March every year to fund raise and raise awareness."

In her spare time, **Karen Loew**, creative director at the **Academy for Continuing Education**, is the **Coast Guard Art Program (COGAP)** Committee Chair of the Salmagundi Club.

The artists of the COGAP immortalize in their paintings the brave men and women who serve our country in the United States Coast Guard. The Salmagundi Club sponsors the national program of artists who give of their time and talent in support of the armed service.

Karen joined COGAP in 1999 and has contributed 17 works of art, 9 of which were created after her deployment to Guantanamo Bay, Cuba in May, 2002.

"The USCG sent me to Guantanamo Bay to document port security by PSU 305 out of Ft. Eustis, VA. This Port Security Unit, comprised primarily of reservists called into extended service, was the

same one that came to New York Harbor right after the 9/11 attacks on our city.

"It was very important to me, since I was selected to tell their story, that I give them proper tribute as a personal thank you. The brave and selfless work of the USCG is the greatest inspiration for creating my art for COGAP.

"This is a family-run foundation that raises money for "discovery grants" for doctors and scientists working on leukemia and allied cancer research. For about 18 years, funds were raised with an annual concert at Carnegie Hall featuring the N.Y. Pops and many, many headliners such as Judy Collins, Maureen McGovern, Skitch Henderson, Marvin Hamlisch, Brian Stokes Mitchell, all of whom had been touched in some way by the scourge of leukemia.

"The first concert I attended, eight or nine years ago," said Judith, "ended with Peter Yarrow singing Puff the Magic Dragon. His final verse described Lauri Strauss, the 26-year-old daughter of Herb and Evelyn Strauss (our founders), who died suddenly of leukemia. I was touched by both the intimacy and poignancy of the experience and vowed then and there to
